Please find enclosed herewith copies of DO letters from CEO, UIDAI vide No.23011/Gen/90/2017/UIDAI-Legal, dated 24.04.2017 and from Secretary, MeitY vide No.NIC/DDG(SBS)/ITACT/2017 dated 24.04.2017 regarding sensitization on compliance to the data sharing provisions of the Aadhaar Act, 2016 and IT Act, 2000.

There have been instances wherein personal identity or information of residents along with Aadhaar numbers and demographic information and other sensitive personal data such as bank details etc. collected by the State Departments for the administration of the welfare schemes have been published online on the departmental websites. The publishing online the identity information is in clear contravention of the provisions of the Aadhaar Act, 2016 which is punishable with imprisonment of upto 3 years. Also, publishing financial information including bank account details is in clear contravention of the provisions under Information Technology (IT) Act, 2000 and the Rules framed thereunder, the violators are liable to pay damages by way of compensation to the affected persons. The concerned departments should ensure that Aadhaar Numbers along with the demographic/personal details are not published on any departmental website.

Dear Chief Secretary/Administrator,

As you are aware that various departments/organizations in your state are collecting and using Aadhaar information of the residents for delivery of subsidies/benefits/services to their beneficiaries in accordance with Section-7 or 57 of Aadhaar Act 2016.

- 2. Your attention is drawn to recent newspaper reports about publishing of personal data of beneficiaries containing Aadhaar number/bank account details by some state departments/organizations in the public domain/on their website. As per various provisions of the Aadhaar Act 2016, inter-alia, section 29(2), 29(3), 29(4) publishing of Aadhaar number or other demographic information is not allowed and such action constitute an offence under section-37,40 and 41, which is punishable with imprisonment up to 3 years.
- 3. In this regard, MeltY has already issued an O.M. dated 25/03/2017 giving direction to all Stake holders including State Governments not to publish Aadhaar number or any other personal information of the individuals in the public domain/website (Copy of the same is enclosed).
- 4. May I therefore request you to sensitize all the departments/organizations in the State who are using Aadhaar in their scheme/programme about their responsibility to protect personal data of their beneficiaries and get any such personal data, if any, removed from the public domain. Further, they may be directed to put in place an adequate mechanism to ensure that Aadhaar number or any other perusal data of their beneficiaries are not published on any website/in public domain.

Dear Secretary,

Kindly refer to the Office Memorandum (OM) No. 10(36)/2015-EG-II (Vol V) Dated: 25.03.2017 on Data Sharing - Compliance of IT Act, 2000 and Aadhaar Act, 2016. The OM is self-explanatory and aims for maintenance of secrecy with respect to personal identity or information of residents.

- 2. It has come to notice that there have been instances wherein personal identity or information of residents, along with Aadhaar numbers and demographic information, and other sensitive personal data such as bank details etc. collected by Ministries/ departments, state departments for the administration of welfare schemes etc. have been published online.
- 3. Publishing identity information i.e. Aadhaar number along with demographic information is in clear contravention of the provisions of the Aadhaar Act, 2016 and constitutes an offence punishable with imprisonment upto 3 years. Further, publishing of financial information including bank details, being sensitive personal data, is also in contravention of provision under IT Act, 2000 with violations liable to pay damages by way of compensation to persons affected.
- 4. In view of the above, the Web Information Managers (WIMs) of all Ministries/
 Departments and State Government departments may kindly sensitize the Ministries/
 Departments and State Government departments respectively and also take all precautions while publishing/ sharing data on their websites, ensuring compliance of the IT Act, 2000 and Aadhaar Act, 2016 with immediate effect. Further, they are also requested to review their website contents/ quality as per the standard guidelines of GIGW, IT Act 2000 and Aadhaar Act 2016. It is also advised that any such contents already published or still appearing publicly, may be discontinued with immediate effect.
